INTRODUCTION TO PRESCIENTIA GROUP OF INSTITUTIONS

'Prescientia' is a combination of two words viz. 'Prescience' and 'Scientia'. 'Prescience' is an English word meaning the fact of gaining knowledge in advance. 'Scientia' meaning 'knowledge', is a Latin word from which the word 'Science' has been derived.

Prescientia Coaching Centre:

Keeping in view of the necessity of a thorough, effective, modern and advanced education system in the secondary as well as senior secondary level at the heart of Hailakandi town, some young energetic academicians being inspired and motivated by some of their known well wishers, suddenly decided to initiate a coaching institute viz. Prescientia Coaching Centre (PCC) in the year 2015. With a remarkably glorious inaugural function at Hailakandi Women's College Auditorium. presided over by the then Hon'ble Principal of Hailakandi Women's College, Sri Bijoy Kumar Dhar, PCC was inaugurated on 8th February, 2020 and practically initiated in a rented building at Shibbari Road, Hailakandi. After one year of financial struggling with very few nos of Higher Secondary students, PCC was shifted to Kalibari Road, Hailakandi in 2016. Along with regular long term and special short term crash courses of HS and competitive exams, PCC has been organizing various academic/ social/ cocurricular activities under Dibakar Trust of Kalibari Road, Hailakandi.

Dedicated and consistent efforts by the faculty as well as students of the institute gradually led this academic initiative a successful one. Students of this coaching centre not only achieved their desired success in Higher Secondary finals but also cracked various prestigious competitive examinations and some got placed in reputed Engineering and Medical colleges of the nation.

Prescientia Senior Secondary School:

After a long wait for 5 years of PCC's inception, the most awaited dream of establishment of a Senior Secondary School at the heart of Hailakandi. Assam came true. The Provisional Prior Permission letter from Department of Secondary Education (DSE), Assam to initiate the Junior College in the year 2020 was received on 19th March, 2020. Hence, amidst the pathetic situation of prolonged global lockdown due to COVID19 pandemic, Prescientia Senior Secondary School (PSSS) of Science & Commerce was established by Dibakar Trust at the same venue of PCC, i.e., Kalibari Road, Hailakandi. Arts stream was initiated in 2023 and in the year 2024 the school's temporary venue was shifted to Tool Road, Hailakandi. 1st academic session for secondary section (Class IX & X) was also initiated in the same year.

SCHOOL UNIFORM


Students must wear school uniform as specified by school authority. If any student, improperly dressed, appears in the school during school hours, then he / she will not be allowed to enter the school premises under any circumstances. However, in this context, a penalty of Rs. 500/may need to be paid in order to attend the school the other day. Moreover, possessing school bag (to be provided by school authority) daily during school hours and wearing navy blue coloured blazer / sweater during winter season (if winter wear is necessary) is also mandatory.



ATTENDANCE

A minimum of 75% annual attendance is mandatory to appear in the final board exam. Daily attendance of students in the 1st and last period shall be recorded. If a student's monthly attendance is found to be less than 75%, then he/she must pay a penalty of Rs. 1,000/- at the school office in order to attend classes in the next month. Submission of all assignments / practical note books / project reports within stipulated time and appearance in all the unit tests is mandatory.

IDENTITY CARD

School identity card will be issued to all the admitted students which must be displayed in individuals while present inside the institute. If any student loses the issued identity card, then it must be immediately reported to school office with a written application letter addressing the Principal with a recent stamp size photograph (in school uniform) of the student for issuing a fresh identity card with a penalty of Rs. 100/-.

COURSES & SYLLABUS

Courses for Higher Secondary 1st year and 2nd year for Science, Arts & Commerce stream shall be conducted. Syllabus as approved and updated by Assam Higher Secondary Education Council (ASSEB Div II) will be followed.

Please Note (Important):

As it is mandatory to take at least 7 subjects in Higher Secondary, hence, a student must take at least 4 elective subjects in addition to the 3 compulsory subjects in a specific stream. Top 5 scoring subjects will be counted for calculation of total percentage of marks in Higher Secondary examination. The mandatory subject Environmental Education is evaluated as Grades only for H.S. 1st Year. If any subject is applied by less than 5 students then the subject won't be taught in the school.

ELIGIBILITY & SEATS

Students who have successfully passed HSLC / 10^{th} standard examination can apply for admission in the school. However, depending upon total no. of available seats in the school per stream (50 only), students will be selected as per their merit based on HSLC result.

ADMISSION GUIDELINES

Students seeking admission for H.S. 1st Year (Science/Arts/Commerce stream) in Prescientia Sen. Sec. School, Hailakandi must follow the mandatory guidelines mentioned as under:

- 1. Correctly filled up FINAL ADMISSION FORM (form to be collected from school office), duly signed by the Candidate as well as Parent / Guardian MUST be submitted to the school office along with the following mandatory requirement:
- (i) Print out of DARPAN Web Portal Online Application Acknowledgement receipt.
- (ii) Photocopy of original HSLC Mark Sheet (to be collected from school).
- (iii) Photocopy of original rovisional HSLC Pass Certificate (to be collected from school).
- (iv) One clear & recent passport sized photo of student (to be pasted on admission form).
- (v) Photocopy of Birth Certificate of student.
- (vi) Photocopy of AADHAAR card of student, father & mother (if available).
- (vii) PEN (mandatory) and APAAR id of student (to be collected from HSLC-school and must be mentioned in in FINAL ADMISSION FORM.)
- (viii) Admission / Total yearly fee

Please Note (Important):

- 1. For any kind of transaction, the screenshot/scanned copy/ photo of the bank receipt or the admission fee receipt must be Whatsapped at 9401083148.
- 2. School bag and authorized identity card will be issued to the students once the school starts its academic session, the expenditure of which is included within the admission fees. Board registration fees and all except final examination fees are also included within the admission fees.
- 3. Same fees as that of H.S. 1st year need to be paid again for admission in Higher Secondary 2nd year also.
- 4. The monthly fees have to be paid regularly after every month and the total yearly fees must be cleared to receive admit card for appearing in the final examination. There is no provision for refund of submitted fees at any cost.

MANDATORY RULES AND REGULATIONS

- 1. Students must possess a minimum of 75% attendance in the school per academic session to qualify for appearing in the final examination. Under special circumstances, if the attendance of any student per academic year is found to be less than 75%, then his / her academic performance in the school (e.g. result in unit tests / half yearly / pre final examination) throughout the academic year must be satisfactory. If a student fails to fulfill both the aforesaid criteria, the school authority shall have the right to disallow the concerned student from appearing in the final examination to be conducted by board (ASSEB). Under any such circumstances, the student / guardian shall have no objection and nobody's request or recommendation to retain the decision shall be entertained by the school authority.
- 2. Guardians of students must clear all the financial dues of the school including admission fees, monthly fees as well as the final examination fees before receiving admit card for appearing in the final / annual board exam of each academic session. Under any circumstances, nobody's request or recommendation shall be considered by school authority for issuing final exam's admit card to any student whose financial dues wouldn't be cleared within the stipulated deadline of fee submission.
- 3. After taking final admission, if any student/guardian suddenly decides to cancel the admission from the school without any considerable cause, the concerned guardian of the student has to pay the total yearly financial dues for which the admission was applied for.
- 4. The school authority will take all the possible necessary actions to take proper care of all the students inside the school campus during academic hours. However, in case, if any student offending the institutional rule of the school meets with any sort of accident due to lack of consciousness, the school authority shall not be responsible for the incidence at any cost and shall not be bound to bear the expenditure for the concerned students' treatment.
- 5. Proper care should be taken by every student with full consciousness so that the assets of school e.g. furniture, school building, electrical appliances, laboratory equipments etc. should not be damaged. If any such damage by any student is noticed, then the concerned guardians of the student has to compensate the same.
- 6. Students must be very careful while moving upstairs & downstairs in the school building.
- 7. Students mustn't leave school premise during school hours without Principal's permission or other faculties. In case of any emergency, the concerned student must inform the Principal as well as his / her parents (through mobile phone of any teacher) and then can leave the school campus.
- 8. Students must appear in all unit tests / exams of each academic session and mandatorily have to pass the qualifying pre final examination to be conducted by the school before appearing in the final yearly board exam.
- 9. If any student, wearing school uniform, is found roaming outside the school campus during school hours without Principal's permission, then he/ she may receive severe punishment.
- 10. Students must appear in all unit tests / exams of each academic session and mandatorily have to pass the qualifying pre final examination to be conducted by the school before appearing in the final yearly board exam.

- 11. Student / guardian, if found to create any unfair means inside or outside the school campus or in social media, that may defame the school or its staffs, the student's candidature from the school may be cancelled by authority.
- 12. Students must appear in all unit tests / exams of each academic session and mandatorily have to pass the qualifying pre final examination to be conducted by the school before appearing in the final yearly board exam.
- 13. Keeping cell phone, digital watch or any other electronic devices inside the school campus is strictly prohibited.
- 14. Students must appear in all unit tests / exams of each academic session and mandatorily have to pass the qualifying pre final examination to be conducted by the school before appearing in the final yearly board exam.
- 15. Students must appear in the school in properly dressed school uniform displaying the issued school identity card.
- 16. Chewing of pan masala, gutka, etc are strictly prohibited inside the school. Any instance of tobacco, alcohol or drug abuse inside the school will lead to permanent rustication of the concerned student/s from the school.
- 17. Bringing bike / scooter in the school as well as parking bike/ scooter in the neighbouring road side of the school is strictly prohibited.
- 18. Ragging is illegal and strictly prohibited both inside and outside the School. If any sort of ragging is reported by the victim or the victim's guardians, rigorous action will be taken against the student involved in ragging.
